ITEM #10 2024 Update to the San Diego Municipal Code

Action Item

The City annually reviews and updates the Municipal Code. This year, the code items address regulatory reforms, compliance with state law, corrections, and amendments to align the code with the City's climate, equity, and housing goals. Amendments affect base zone regulations, Community Plan Implementation Overlay Zones, landscape regulations, residential care facilities including behavioral health facilities, visitor accommodations, and urgent care facilities. The Board will review relevant changes and consider sending comments to the City Council.
