Declaration of Candidacy Application for Rancho Bernardo Elections to the Rancho Bernardo Community Planning Board

The Rancho Bernardo Community Planning Board is an officially recognized community planning group in the City of San Diego. Operating in accordance with City Council Policy 600-24 and adopted Bylaws, the RBCPB advises the SD City Council, Planning Commission, and other decision-makers on development projects and land use issues

ELECTION DATE: SATURDAY MARCH 3, 2012

Who is Eligible: Candidates must have been residents of Rancho Bernardo for a minimum of 30 days and at least 18 years of age. Candidates must reside in their specific district and **attend at least one meeting** prior to the Election within the election year (March – March).

Area Represented: Planning Board Members are elected by the specific district in which they live. *(See Descriptions of Districts on reverse side.)*

Steps to Apply: Candidates must complete the Declaration of Candidacy Application and submit it to the Election Committee per the instructions below. The candidate’s name will appear on the ballot in an order to be determined by a drawn lot. If a picture of the candidate is attached, the candidate agrees that the picture may be published in the local newspaper, newsletter, or other election materials and will not be returned.

COMPLETE THE FOLLOWING INFORMATION:

1. Write a 25-word message to the voters *on the reverse side of this form*, or attach it to this form. This may be used in newspaper and newsletter publications.
2. **Deadline:** Declaration of Candidacy Applications must be postmarked or received on or before 11:59 p.m. on January 31, 2012. Mail the application to RB Planning Board, PO Box 270831, San Diego, CA 92198, or give it to one of the Election Committee members listed below.

District E: All residents living in the communities of Seven Oaks and the Remington Club.

District F: All residents living in the community of Bernardo Heights.

District G: All residents living in the communities of High Country West, Camino Bernardo, Deerwood, The Falls and The Villas.
